Dana requested review and approval of prior minutes at the start of each meeting. The January 11, 2017 minutes were reviewed and approved unanimously with no changes.

#### Discussion items

- 1. Financial Update / 2017 Budget
  - January income is missing a \$10K that was received but not yet deposited
  - AHOTO 2016 netted about \$30K
  - Our fixed expenses are running about 30%
  - Elise mentioned that \$1K had been allocated from the special use fund to DAWG for S/N and vaccines through Spay Neuter Network
  - Elise also informed us that she had to renew the lease or the cost was going to escalate
  - Melissa volunteered to help with any grant applications if we found ones that we thought we could apply for
- 2. Continued discussion about percentage of Overhead related to Income and what constitutes overhead
  - There are differing interpretations of which expenses must be categorized as overhead. Suggestion was made to get a professional to make a ruling. Melissa agreed to take an action to get a quote for an independent audit.
- 3. Proposal to hire weekend help since Saturday 8PM shift hard to fill
  - Elise was going to talk to Renae about her interest/willingness to work additional Saturday shifts
